

DIRECT DEPOSIT AND ONLINE DETAIL

Dear Interest Owner:

Circle-S Energy LLC offers the option to receive revenue payments via Direct Deposit. This service provides the following benefits to our owners:

- Your payment will be deposited automatically to your account without interruptions due to travel, illness, etc.
- Service is provided at no cost to you
- No lost checks or guessing when funds will be received
- Immediate access to funds

In order to take advantage of this benefit you must complete and return the enclosed form – “Authorization for Electronic Fund Transfer Payments” along with a voided check. You must also be able to access information on-line as any owner choosing Direct Deposit will no longer receive their revenue detail by mail.

Circle-S Energy LLC has partnered with EnergyLink to provide a website that will allow you to access your revenue statements each month. Utilizing a secure login, you will be able to view, download or print your current and archived payment information.

If you are registered with EnergyLink, you should see your check detail statements automatically under your login. If you do not see it in your EnergyLink account or you have never used EnergyLink, you have a few options to view your check detail.

1. New users will need to self-register on EnergyLink’s website <https://app.energylink.com> and click on ‘Signup’ located at the top of the webpage. You will need your recent payment information to complete registration.
2. Contact EnergyLink Support team at <https://app.energylink.com> and click on the ‘Contact Us’ green bubble in the webpage’s lower right-hand section.

If you choose not to participate in Direct Deposit or if you have previously provided your information, please disregard this notice.

AUTHORIZATION FOR ELECTRONIC FUNDS TRANSFER PAYMENTS

If you have already signed up for direct deposit for this owner number, you **DO NOT** need to sign up for new well(s). The first time you sign up will cover all future wells(s).

The undersigned, hereinafter called "Owner", is representing that Owner is the owner of an oil, gas and/or mineral interest that is currently paid by Circle-S Energy LLC, hereinafter called "CSE". Owner hereby authorizes CSE to make direct deposit (EFT) payments for Owner's owned interest to the financial institution and owner account as designated below. In the event CSE deposits funds erroneously into Owner's account, Owner hereby authorizes CSE to debit Owner's account for an amount not to exceed the original amount of the erroneous credit.

Owner agrees that electing to participate in EFT payments will not amend any lease agreements between CSE and Owner. This agreement simply allows for EFT payments in lieu of paper check payments.

This Authorization shall remain in full force and effect until CSE and the depository institution listed below have received written notice from Owner of its termination in such time and in such manner as to afford CSE and the depository institution reasonable opportunity to act on it. Owner agrees to give thirty (30) days' advance written notice of any change in the payment instructions shown below. Owner agrees that any changes to Owner's mailing address will continue to be submitted in writing to CSE. Owner agrees that CSE will not be held liable for any interest or other claim arising as the result of Owner's failure to provide written notice of any payment instruction changes. Owner also releases and agrees to indemnify and hold CSE harmless for any loss, claim, damage or interest incurred as a result of Owner's depository institution's failure to properly or promptly post any EFT payment and/or as a result of any error or omission in the payment instructions provided by or on behalf of Owner.
